CLUB ROOM RULES AND REGULATIONS

THE FOLLOWING SHALL BE ADMITTED:

- A. ALL MEMBERS OF THE AMERICAN LEGION SHOWING CURRENT AMERICAN LEGION CARD AND WIFE/HUSBAND OR ESCORT**
- B. ALL MEMBERS OF THE LEGION AUXILIARY SHOWING CURRENT CARD AND HUSBAND OR ESCORT**
- C. ALL MEMBERS OF THE SONS OF THE AMERICAN LEGION SHOWING CURRENT CARD AND WIFE OR ESCORT**
- D. GUESTS NOT TO EXCEED SIX (6) PERSONS PER MEMBER SHALL BE ADMITTED WHEN ACCOMPANIED BY A POST 320 MEMBER. ALL GUESTS MUST SIGN IN. IF THE POST 320 MEMBER LEAVES THE POST, ALL GUESTS MUST LEAVE WITH HIM/HER. EACH POST 320 MEMBER IS RESPONSIBLE FOR HIS/HER GUEST. ALL LOCAL RESIDENT GUESTS ARE RESTRICTED TO ONE (1) CLUB VISIT PER MONTH.**
- E. ADULT ACTIVITIES ARE NOT APPROPRIATE FOR CHILDREN. IF CHILDREN ACCOMPANY THE MEMBER PARENT, THE MEMBER PARENT MUST STAY ON THE PREMISES. NO CHILDREN WILL BE LEFT UNSUPERVISED**
 - 1.) NO SMOKING IN THE POST BUILDING ALLOWED (ONLY OUTSIDE).**
 - 2.) NO PROFANITY OR ABUSIVE LANGUAGE ALLOWED**
 - 3.) MUST BE 21 YEARS OF AGE TO CONSUME OR POSSES ALCOHOLIC DRINKS**
 - 4.) THERE SHALL BE ABSOLUTELY NO ALCOHOLIC DRINKS OF ANY KIND TAKEN FROM THE PREMISES AT ANY TIME.**
 - 5.) ONLY THE ON DUTY ATTENDENT OR MANGER SHALL BE ALLOWED BEHIND THE BAR DURING CLUB OPERATIONS**
 - 6.) ALL LIQUOR BOTTLES MUST HAVE THE OWNER MEMBERS NAME ON IT.**
 - 7.) NO DISORDERLY CONDUCT ALLOWED (AUTOMATIC SUSPENSION OF CLUB PRIVILEGES; LENGTH OF SUSPENSION TO BE DETERMINED BY THE EXECUTIVE BOARD).**
 - 8.) NO GAMBLING IS ALLOWED IN THE CLUB UNTIL PROPER LICENSE HAS BEEN AQUIRED**
 - 9.) NO MEMBER SHALL REPRIMAND AN OFFICER, OR ATTENDANT OR MANAGER OF THE CLUB. ANY SUGGESTION OR CRITICISM OF THE CLUB OR LEGION OPERATION SHALL BE SUBMITTED TO THE EXECUTIVE BOARD, AND IT WILL BE GIVEN DUE CONSIDERATION.**
